**WAIVER OF LIABILITY**

I am aware that playing golf, and the mere act of being present on a golf course, are activities that pose potentially serious risks of injuries or death to their participants. I am aware of the intrinsic dangers that are associated with being on a golf course. I understand that my child could be injured as a result of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which he or she is going to be engaged.

By signing this waiver, I accept that there are intrinsic dangers associated with being present on a golf course, and with playing golf. I accept that injuries could occur through no fault of my child or anyone around him/her. I recognize that there is an unpredictability associated with one's safety while present on a golf course.

This waiver shall remain valid unless expressly revoked by the parent or guardian of a minor, in writing, with receipt acknowledged by the Farmville Golf Course.

With the knowledge of the foregoing, and as an inducement for the Farmville Golf Course to allow my child to participated in golf related activities, including lessons and instruction, I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against the Farmville Golf Course, any of its employees, volunteers or participants, the Town of Farmville, or any employees of officials of the Town, arising from any damages, injury, or death which my child might sustain or which might occur to my child as a result of his or her participation. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from any activities engaged in by my child at the Farmville Golf Course.

4. That this Agreement shall be governed by the laws of the Commonwealth of Virginia.
5. That in the event any portion of this Release shall be declared invalid, unenforceable or void by a court of competent jurisdiction, the remaining provisions of this Release shall remain in full force and effect.
